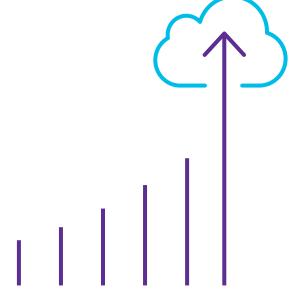

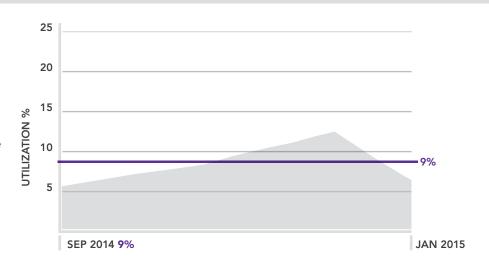


Let's do the numbers
